Recently in the General Assembly, legislation was passed regarding sports physical exams done in compliance with KHSAA Bylaw 2. Please be mindful of the fact that this change does not go into effect until July 14, 2002. Until that time, sports physical exams must be signed by a Doctor of Osteopathy or Medical Doctor.

Also, the Kentucky Medical Association recently completed work in conjunction with the KHSAA on an informational component and recommendations regarding heat illness prevention.
