- The coach will confirm with the athletic director that they have checked the list and notify the athletic director of any athlete who has not met the minimum credit amount for that season prior to any participation.

Dear Mr. Sandifer:

This letter is in response to your recent correspondence self-reporting a KHSAA Bylaw 5 violation concerning Devon Dickens, a student at Daviess County High School ("DCHS"). I appreciate the initiative you have taken by self-reporting this violation.

KHSAA Bylaw 5, Section 1 states: On the first day of each school year, a student must be at his/her proper grade level. To be considered to be at the proper grade level, a student must have been enrolled during the previous grading period, and must be on schedule to graduate on the first day of school. For the verification of this provision, all course work, including summer and correspondence work, must be complete by the first day of the school year for the student body.

KHSAA Bylaw 9, Case 3 states: If a participant is ineligible he/she may not tryout, practice, or participate in games or scrimmages until eligible and minimum practice periods (i.e. ten days for football) do not begin accumulating until the ruling is complete. Ineligible persons practicing with the team jeopardize the insurance coverage of all participants and the liability coverage of the school, school system and individual coverage. The only exception to this policy is the practice of otherwise eligible students who are not eligible for the team's next contest due to the penalty for sportsmanship violations (Bylaw 11).

After reviewing your letter and the additional documentation you submitted, it appears that this student-athlete was not at grade level and was classified as a repeating freshmen during the fall of the 2009-2010 school year. Therefore, you are correct in your interpretation of Bylaw 5, Section 1(b), that he was ineligible to participate in interscholastic athletics this past fall when he competed in varsity and junior varsity football at Daviess County High School.

Allowing ineligible students to practice and participate in high school athletics is a serious KHSAA violation due in part by the lack of insurance coverage for this student. As a result of this violation, Daviess County High School personnel are required to do the following:

The purpose of this letter is to report a possible eligibility issue with a current student athlete at Daviess County High School. On February 23, 2010, while reviewing school attendance records, we discovered a "credit" situation. After confirmation with one of our counselors, we found that one of our students earned five out of a possible eight credits during the 2008-2009 school year. At Daviess County High School, we currently retain students unless they earn a specific amount of credits. In addition, we operate on a "4 x 4 block" schedule, where students typically earn four credits each semester.

Description of Issue

Devon Dickens participated in junior varsity and varsity football during the 2009 season. Neither the head coach nor any school administrators realized that **Devon** did not have the required 20% of the graduation requirement fulfilled when beginning the fall season. He earned 5 credits and our minimum graduation requirement is 26 credits. **To meet the "20%" rule, he needed 5.2 credits.** The athlete was eligible based on our weekly grade report, but the credit issue went unnoticed throughout the fall season.

Explanation

This was simply an oversight by the head football coach and the athletic director. At the end of each school year, our guidance department sends out a list of retained students, and in this athlete's case, his name was overlooked.

Solution (To Eliminate Reoccurrences)

Beginning with the 2010 spring sports season, we will implement a plan that requires coaches to send their full roster of athletes to Mr. Pat Hume (counselor and head varsity girls' basketball coach) before they play their first game. This will ensure that all participating athletes have met the minimum amount of credits and are eligible to compete. Mr. Hume will then inform the Head Coach, Athletic Director, and Principal if any athlete is ineligible because of insufficient credits. Our counseling department will continue to distribute a list of students with insufficient credits toward the end of each school year. We will then require our coaches to sign a written document and file in the athletic director's office.

Enclosed with this letter is a copy of Devon Dickens' participation level and statistics in football as well as a sample of our weekly grade report.

Please be assured that he was not allowed to participate in order to gain any advantage. We regret this issue and have already taken steps to keep this situation from happening again.
