As the representatives of this school, we request to be withdrawn from football championship competition in 2011 through 2014. We understand that we will be out of district competition until the end of the classification cycle.

As the representatives of this school, we request that the following suggested amendments to the alignment of schools in football be given consideration by the KHSAA Board of Control with respect to this school (attach additional if necessary):

Russell High School respectfully request that the proposed alignment for the 2011-2014 football seasons be amended to include Russell High School in Class 3A District 6 and drop Russell High School from Class 2A District 8. This request is based solely on geographical concerns and will let us remain playing four teams that are in our current football district and four that are in our basketball region and three within 1 hour of our school. Our placement in Class 2 A would have us traveling at least 2 hours or more to three of our district opponents and possible trips of 4 hours in the playoffs. It is also our understanding that with requests of other schools that our void in class 2A would be filled by other schools requesting to move into our vacated district placement. Please see attached mileages that may help you understand the travel we are discussing.
