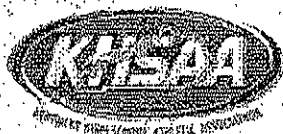

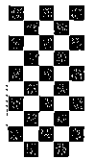

To Mr. Tackett,

Cooper High School is requesting to be eligible to be placed into the 5A classification when the final alignment is developed for the 2011 season. We understand that we will remain in the 5A classification for the entire alignment period. The representatives of Cooper High School would like the KHSAA to consider the 5A classification due to Cooper being a new school and having a substantial growth. In the **2008/2009 school year**, which was the first year of the new school, Cooper's male enrollment was **403**. In the **2009/2010 school year** the male enrollment was **485**. This **current school year** our male enrollment is **539** which by the new alignment numbers would place Cooper in the 5A classification. The average growth over the past two years is **68** students per year. If we average the same growth next school year our enrollment will have us in the mid range of 5A. The Boone County School Board projections continue to have Cooper growing over the next several years.

Cooper feels the 5A classification would be best not only for Cooper High School but also for the other Northern Kentucky 5A schools. Currently there are three NKY schools which are aligned to play in the 5A classification. One of these three schools is also a member of the Boone County School District. Placing Cooper High School in the 5A classification would eliminate another 5A school to have to travel to NKY to play in the 5A district. If Cooper High school is granted permission from the KHSAA to play in the 5A classification the projected NKY 5A district would all be within 25 miles of one another.

Concerning the impending football realignment, at this time Harrison County High School is requesting to be moved up from 4A to 5A. In looking at all the feasible scenarios, it is apparent to us that, geographically, moving up one class will give us the best opportunity to reduce our travel expenses and maintain more natural rivalries that we have developed over the years.

Cost of travel is the over-riding concern of our administration and our football coach. All travel expenses are taken directly from the revenue generated from our football gate receipts. We consider ourselves a part of the Bluegrass Region and would like to be placed in a "Bluegrass District". Historically, teams from Central Kentucky "travel well", if their teams play a reasonable distance from home against traditional opponents.

We feel that not only will a move up to 5A reduce travel significantly, along with those corresponding travel expenses, but that the attendance at both home and away games will be much better for all the teams involved. In this day and age, the almighty dollar is usually the determining factor in the "health" of any sports program. Our community in Harrison County is not economically burgeoning. We are somewhat stagnant with little economic growth. Our tax base is not growing and we need to take every step we can to promote our athletic programs.

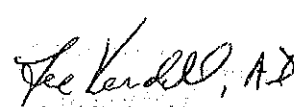

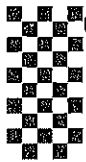

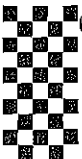

Ohio County High School respectfully requests to play in a higher class for the 2011 alignment. Currently Ohio County plays a 5A schedule and the district includes Christian County, Hopkinsville, Madisonville North Hopkins, and Owensboro. Under the proposed realignment Madisonville North Hopkins and Owensboro will move to 4A, leaving Hopkinsville, Christian County and Ohio County. The geographic possibility of Graves County and Apollo being added would make an interesting district alignment. Geographically Apollo is approximately 25 miles from Ohio County High School, while Hopkinsville and Christian County would require a 2 hour of travel and Graves County over 2 ½ hour travel time.

If permitted to play in 6A the possible alignment could place Ohio County with Muhlenberg County, Daviess County and Henderson County. These three schools would require an hour or less travel time, thus not requiring Ohio County to make a long distance road trip for district play.

Ohio County is open to other suggestions from the KHSAA, and willing to discuss this further if necessary.

Concerning the impending football realignment, Pendleton County High School is requesting to be moved up from 4A to 5A.

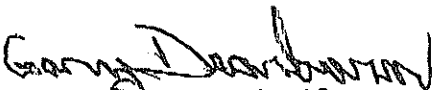
Cost of travel is the over-riding concern of our administration and our football coach. All travel expenses are taken directly from the revenue generated from our football gate receipts. We consider ourselves a part of the Bluegrass Region and would like to be placed in a "Bluegrass District". Historically, teams from Central Kentucky "travel well", if their teams play a reasonable distance from home against traditional opponents. We have found that some of our northern Ky. schools do not bring fans to our school and community.

We feel that not only will a move up to 5A reduce travel significantly, along with those corresponding travel expenses, but that the attendance at both home and away games will be much better for all the teams involved. In this day and age, the almighty dollar is usually the determining factor in the "health" of any sports program. We are much like other athletic programs in our Commonwealth in that we are struggling to make ends meet and anything that we can do to assist in cutting travel expenses and have fans to follow teams will enhance our athletic programs.
