GENERAL INSTRUCTIONS AND GUIDELINES

- I) This important form is turned in once every three years by the member schools of the KHSAA. This form serves two primary purposes –
 - A) Provide the National Federation of State High School Associations (NFHS) with participation numbers for the development of rules and regulations.
 - B) For the purpose of determining the level of interest in adding a new sport or sport activity or continuing an existing activity. These results are reported to the Board of Control of the KHSAA and are binding as to the adopted policies of the Board related to adding or deleting a championship offering.
- II) It is imperative that you file this survey with the KHSAA prior to **June 9 2008**.
- III) Failure to complete this form in a timely manner could result in penalties against the school athletic program as this is vitally important information.

SPECIFIC INSTRUCTIONS

- I) The form is divided into four sections.
- II) Section 1 – Current Individual Participation – This section deals with participation levels of current KHSAA championship sports and/or sports activities.
 - A) This section contains the sports and sports activities for which the KHSAA sponsors a championship currently (this section also includes cheerleading totals).
 - B) In the two columns of this section (labeled CURRENT INDIVIDUAL PARTICIPATION), list sport by sport the total number of participants. Include, freshman, JV and varsity totals.
 - C) In the cheerleading row, list number of students entering competitions representing school in allowable Bylaw 25 competitions AND/OR who participate supporting a KHSAA team (i.e. sideline cheer). List # of boys who cheer, girls who cheer, not competition gender)
- III) Section 2 – Future Team Participation/Lack of Participation
 - A) In the two columns of this section (labeled FUTURE TEAM PARTICIPATION), place an “X” beside each sport in which your school will be adding interscholastic competition beginning in 2008-2009 but did not compete in 2007-2008.
 - B) In the two columns of this section (labeled FUTURE TEAM PARTICIPATION/LACK OF PARTICIPATION), place a “D” beside each sport in which your school will be dropping a sport that was previously conducted.
 - C) Do not mark any sport that your school had in 2007-2008 and will continue having in future years.
- IV) Section 3 – Participants in Non KHSAA Activities/Sports
 - A) In the two columns of this section (labeled PARTICIPANTS IN NON KHSAA ACTIVITIES/SPORTS), list the number of participants in these particular offerings that currently represent your school. Many schools have “club” teams and others that participate in these activities and sports against other schools.
 - B) Do not include numbers that are exclusively intramural.
- V) Section 4 – Would Enter a Team if KHSAA Had a Championship
 - A) In the two columns of this section (labeled WOULD ENTER A TEAM IF KHSAA HAD A CHAMPIONSHIP), place an “X” beside each sport in which your school would like to participate if the KHSAA sponsored a championship in that particular activity/sport.
 - B) The Board of Control adopted policy is to offer a championship in a sport or sport/activity when 20% of the member schools desire to have such a championship.

- VI) The form should be signed by the Principal and the Athletic Director at the school and submitted prior to **June 9, 2008**.
