David was an extraordinary cross country runner as well as an outstanding Track and Field Runner. His credentials speak for themselves. David was a 3 time individual cross country state champion. During that period of time, Daviess County won the AAA state championship in 1998. David is also a 3 time state champion in the 1600M and 3200M and 4x800 relay team in Track and field. During that period of time, Daviess County won the AAA Track state title in 1997 & 1999. David Christian is a 2 time Footlocker finalist in Cross Country. During his College career at North Carolina State University, David was All Atlantic Coast Conference in Cross Country (2 times) and Track and Field (2 times). After his collegiate career, David took a teaching and coaching position at Broughton High School in Raleigh, North Carolina. He turned a program around to win 2 AAAA state Championships in Cross Country (2007 & 2008). In 2008 his team placed 2nd in the NIKE Cross Country Team Regional Championships (3rd place was Daviess County). David has had equal success at coaching high school track and field. His coaching personal best records are as follows: 4x800 relay (7:51); 800M (1:53); 1600M (4:08); 3200M (8:56); and in cross country: 5K (15:03). During the summer of 2009, David Christian furthered his career by speaking at the NIKE Smoky Mountain Running Camp in Ashville, North Carolina.
