The Basketball Officiating Career of Gerald L " Jerry " Gilbert

Became Registered to Officiate Basketball as a KHSAA Official in 1956  
Officiated approximately 40 Junior Varsity games in the season of 1956-1957.  
Went with Howard Gardner and Bill Osborne the entire season and officiated all of their JV games.

Officiated every year after that until the season of 1982-1983 with the exception of a 3 year break when I did not officiate because I had changed jobs and I felt my new position could possibly create a conflict of interest situation. However, I was encouraged by Mr Gardner to renew my career as he felt that my fears were unfounded. Thus, I returned to what I had loved for a long time. I had officiated on the college level during that 3 year period but now I was returning to my first love and that was to be part of Kentucky High School Basketball. I have enclosed a list of what I consider the highlights of my officiating career. I am providing the large majority of this information from memory, which at the age of 74 is certainly not as sharp as it once was.

Afterward, the scorekeeper called us to the scorer's table to ask who the technical was on. My partner said it was on #52. The scorekeeper then said that there was not a #52 in the game. I then asked him who the technical was on. He then pointed to the player that I had called for goal-tending. I asked him if the technical was for vibrating the backboard. He said yes. I told him that we could not call him for a technical for that as he hit the ball and was charged with goal-tending. My obligation is to the ten young men on the floor to be as fair as I can possibly be to them and what we were about to do was not fair and it was correctable and I was going to correct it with no regard how the coaches felt about my decision. The one person I have to please is me. As long as I have done all I can do to be fair to the players on that floor, then I feel I have done my job.

In the final analysis, I can honestly say that my years of officiating has been a complete joy to me to be connected to Kentucky High School Basketball for so many years. Also, I really appreciate the relationships that I have developed with some of the finest people involved in High School sports. There are so many that if I attempt to name them all, I fear I would forget someone that I should mention. Several of those have passed on but I still remember many of them. One in particular is the one that I call my mentor, Mr Howard Gardner, who I must say in all honesty was one of the finest people I have ever known. I also have the utmost regard and respect for former Commissioner Billy Wise, who will be submitting my application for induction. I submit this information with much humility and gratefulness to be considered among such an elite group.

I am writing this letter on behalf of Jerry Gilbert, one of the finest basketball officials that ever called high school basketball games in the state of Kentucky. I coached for several years at Richmond Madison High School along with many years at Elizabethtown High School and Jerry called numerous games while I was coaching.

During the 1970 State High School Basketball Tournament, I first became aware of what an outstanding basketball official Jerry Gilbert was. I watched him call three games during that tournament and I quickly recognized what an outstanding job he did. My team played in the semi-final game that year, and it was my hope that it would be Jerry to call that game. Jerry ended up being one of the officials and that night I became a Jerry Gilbert fan right then and there. Jerry had a demeanor about him and everyone in the gym knew that he was in charge of the game and he was confident about what he was doing...this included coaches, players, and fans. He had an uncanny ability to make the right call even in tough situations. Jerry always remained cool in tight games even when there was a lot of hostility between rivalries.

Jerry officiated during a time when the coaches voted on the officials to call the tournament. Jerry was voted to work countless District and Regional Tournament games. This clearly explains what coaches thought of him as an official. Not only was he voted to call the tournaments, but he worked the championship games in almost every District and Regional Tournament that he was officiating. I believe that says it all about Jerry as a basketball official.

To my knowledge, Jerry worked the Basketball State Tournament in 1970, 1971, 1979, and 1981. During these years, he officiated the championship game three times and one State semi-final game. It would be hard to find any other official who has a record that would match Jerry's.

Not only was Jerry one of the best officials that ever put the stripes on, he is a class act as a person. He is what people should be. I, as well as, those who know him have the highest regard and respect for him as a person.

It is my hope that you will give Jerry Gilbert the consideration he deserves and honor him by inducting him into the 2012 Dawahares KHSAA Hall of Fame.

Jerry and I worked many basketball games together in the early eighties and during this time he was one of the best friends and officials that the KHSAA could have. His career stems back to 1961 when he worked his first district basketball tournament at Meade County High School and from that point on he worked several district tournament throughout the sixties through the early eighties. He worked his first Regional Tournament in 1965 at E.A. Diddle Arena for Glasgow high school against the famed F. B. I have known Jerry for many years. We first were acquainted while playing high school basketball. Jerry played for Vine Grove High School, and I played for Sonora High School. Both of these schools are now consolidated schools in Hardin County.

For several years, when I was a young coach and Jerry had coal black hair instead of his now white hair, I often referred to him as a promising young official. It is obvious that Jerry more than lived up to that promise but also became what I considered and many other coaches that I knew considered as well among the very best in this state. From there, Jerry very well could be considered the very best as he officiated 3 State Championship games. As a sportscaster at the time, I recall that all 3 games were played without any controversies. Also, as I recall, there were no comments after each of those games, either positive or negative, about the officiating. That says volumes about the efficiency of the officiating. Also, the one common denominator in those games was Jerry as the other official was three different officials.
