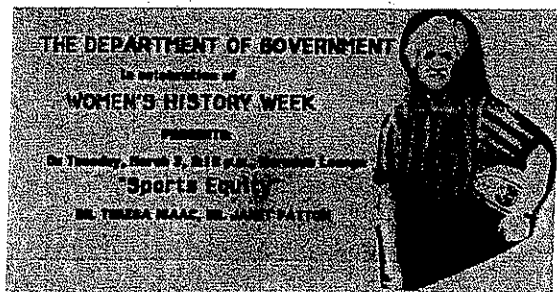
# Looking back...

## Sex Discrimination in Basketball Refereeing — A Family Affair

The Isaacs of Lexington were a force to be considered in women's basketball. Mother Barbara Ann was a star player, winning the Virginia State Basketball Tournament in 1952, and then a referee. Several daughters, including Mary Alene and Teresa Ann also were players. Teresa Ann Isaac, who is currently the Mayor of Lexington, was, in 1986, the Chairperson of the Central Kentucky chapter of the ACLU of Kentucky and an ACLU cooperating attorney.

Because "basketball is a religion" in Kentucky, perhaps the suit against the Kentucky High School Athletic Association (KHSAA) and the State Board of Education, brought by ACLU cooperating attorney Isaac, should have cited the First Amendment of the United States Constitution. Rather, the suit alleging gender discrimination in the selection and assignment of basketball referees claimed violations of the Kentucky legislation (KRS 344.040) that proscribes employment discrimination, Section 2 of the Kentucky Constitution that prohibits the exercise of absolute and arbitrary power over the lives of Kentuckians, and the Fourteenth Amendment of the United States Constitution that guarantees

due process and equal protection of the laws to all citizens.

In 1986, 15 years after the ACLU of Kentucky successfully forced the KHSAA to provide a real voice for African-Americans on its Board of Control and in its activities, including basketball tournaments, and 12 years after the passage of state legislation requiring girls high school basketball teams in schools that had a boys team (KRS 157.340 (5)), there were no women assigned to referee either the boys or the girls state tournament.

The KHSAA had pledged in 1974 to affirmatively recruit women officials, but the results 12 years later were not particularly improved. Even though, overall, the number of women referees (30) was significantly fewer than the number of men (1,470), several of the women were highly qualified and experienced. However, the selection process in place at the time was distinctly biased in favor of the men. The KHSAA maintained that the process was based solely on merit, but it depended on subjective ratings by male coaches and by male assigning secretaries. The assignment process had the effect of continuing to limit the placement of women officials in regular season games, as well as district, regional, invitational, and state tournaments.

Attorney Isaac filed suit in March of 1986, as the state tournaments were about to begin, on behalf of four women referees, including her mother. The suit was amended in April to include her 13-year old sister, who claimed in the suit that she, as a Bryan Station high school player who hoped one day to become a referee, was also being discriminated against because of the absence of women referees. The complaint asked for an in-

junction against the State School Board and the KHSAA and damages for the plaintiffs.

The suit was big news because it threatened to possibly interfere with the state tournaments and to upset the comfortable, male-dominated KHSAA, but there also was significant support for the women. On May 6, 1986 the *Lexington Herald-Leader* editorialized that the suit was "an effort to strike back at ... paternalistic discrimination," and continued by saying, "Here's hoping the state school board and the KHSAA will turn their considerable resources toward remedying the problem now, rather than continuing to cower behind the so-called rules that keep it in place."

Ultimately, the KHSAA and the School Board did settle the case by an agreement to add more women officials and to recruit and train them across the state. Also, the KHSAA added two women to its Board of Control and, interestingly, Teresa Isaac eventually served on the Board of the KHSAA. Brigid DeVries, who was the Assistant Commissioner of the KHSAA during the litigation, is actually the Commissioner now.
